OWNERSHIP ASSIGNMENT

Upon presentation of documentation that the Funeral Establishment has provided funeral services and merchandise for the insured upon the insured's death, NCM Life Insurance Company is directed to pay the proceeds of this Policy to said Funeral Establishment, as its interests may appear, and the remainder, if any, to the beneficiary named in the Policy.

I HEREBY ACKNOWLEDGE THAT:

1. No Irrevocable Assignment Of Ownership, Benefits Or Rights In The Policy Exists;
2. This Assignment Revokes And Supersedes Any Prior Revocable Assignment Of The Proceeds Or Other Benefits Of The Policy;
3. I Reserve The Right To Revoke This Assignment By Giving Written Notice Of The Revocation To The Funeral Establishment Prior To The Delivery Of The Funeral Service Or Merchandise, Revocation Effective Upon Receipt;
4. I Waive All Rights Under The Policy To:
(i) Surrender The Policy For Cash; (ii) Obtain A Loan Against The Policy; (iii) Change The Beneficiary;
5. *I Do Not* Assign The Rights Waived Above To Any Other Person, Including The Funeral Establishment And The Use Of The Proceeds Of The Policy Is Limited To The Funding Of The Cost Of The Funeral Services And Merchandise;
6. If The Funeral Establishment Cannot Meet Its Obligations Under The Funeral Planning Agreement, The Funeral Planner Of That Agreement, If Living, Otherwise The Beneficiary, May Select Another Establishment, Which Shall Be Entitled To Receive The Proceeds In Return For The Delivery Of Comparable Funeral Merchandise And Services.
7. NCM Life Insurance Company Shall Have No Responsibility Whatsoever For The Validity, Sufficiency Or Effect Of This Assignment. Payment of The Death Benefit By NCM Life Insurance Company In Accordance With The Terms Of This Assignment Shall Release The Insurance Company From Any Further Obligation Under The Policy. This Assignment Shall Be Binding On The Insurance Company Only When An Executed Original Or A Duplicate Thereof Is Filed At Its Home Office.
